c. Revise the product's name to read as follows;

"Red Cross Nurse Brand Disinfectant & Air Deodorizer"

d. Revise the first aid statement to read as:

FIRST AID

IF ON SKIN OR CLOTHING:

- Take off contaminated clothing
- Rinse skin immediately with plenty of water for 15-20 minutes.
- Call a Poison Control Center or doctor for treatment advice

e. Revise the precautionary statement to read as follows:
