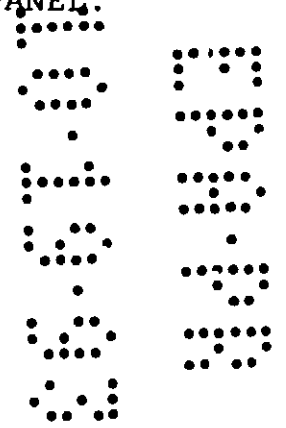

PRECAUTIONARY STATEMENTS
HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

This product is not designed to be a space spray for flying insects. Do not spray food, humans or pets. Do not use in commercial food preparation areas or in edible products areas of food processing plants. Harmful if swallowed. Do not allow children in treated areas until surfaces are dry. Wash after handling and before eating or smoking. Avoid prolonged and repeated contact with skin. In case of contact, wash with soap and water. Avoid inhalation. To avoid possible staining test first in any inconspicuous place and check results the following day.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Keep out of lakes, streams, tidal marshes and estuaries. Do not apply directly to water or to areas where surface water is present. Do not contaminate water by disposal.

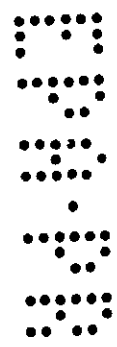
PHYSICAL OR CHEMICAL HAZARDS

FLAMMABLE: Do not spray into or near open flames. Do not smoke while using. Contents under pressure. Keep container away from stoves, radiators, or other hot surfaces. Temperatures exceeding 130°F. may cause bursting. Do not puncture or incinerate. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor covering.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed - Call a physician or Poison Control Center immediately. Gastric lavage is indicated if material was taken internally. **DO NOT INDUCE VOMITING.** Vomiting may cause aspiration pneumonia.
If Inhaled - Remove victim to fresh air. Apply artificial respiration if indicated.
If On Skin - Remove contaminated clothing and wash affected areas with soap and water.
If In Eyes - Flush eyes with plenty of water. Get medical attention if irritation persists.

NOTE TO PHYSICIAN: This product contains an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered but only in conjunction with atropine. This product contains petroleum distillate solvent which may present an aspiration hazard. Gastric lavage may be indicated if product was taken internally.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

GENERAL: Spray surface to wetting. Point spray away from people, plants and pets.

INDOOR USE: Ants, Cockroaches, Crickets, Silverfish, Spiders, Scorpions, Saw-toothed Grain Beetles (exposed stage), Waterbugs: Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Repeat as needed. Do not spray foodstuffs or house plants. Discard foodstuffs that come in contact with ROACH AND ANT KILLER. For ants, spray trails and places where ants enter premises. Do not allow children to contact treated surfaces until surfaces are completely dry.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

OUTDOOR USE: Ants, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sowbugs, and Brown Dog Ticks: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames foundations, patios or other places where insects may enter. For ants, spray hill and runways. Repeat as necessary. Do not spray vegetation.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard containers in trash. Do not incinerate or puncture.
