

### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

For Control Of Wasps and Hornets: Apply after dark when all of the insects have returned to the nest. Aim valve opening at nest and depress button, soaking the nest with the spray. Repeat as necessary. Avoid wetting vegetation with the spray, as it will be damaged. Do not use as a space spray. Spray infested areas such as under porches, eaves, door and window frames.

OUTDOOR CNLY. Other Uses: For control of Ants, Clover Mites, Crickets, Earwigs, Millipedes, Sowbugs and Brown Ticks: Spray infested area thoroughly including outside surfaces of screen frames, doors, window frames, foundation, patios and other places where insects may enter or harbor. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation. Do not use as a space sprav. Avoid excessive wetting of plastics, rubber and asphalt surfaces of patios.
