For Control of Wasps, Hornets, Bees, Yellow Jackets. Point valve opening toward nest, crevice or hole where infestation of insects are known to be inside. Depress button, continuing to spray until the nest or the area sprayed is completely saturated. Application at night after the insects have returned to their nest is preferable. Repeat as necessary.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in a cool area away from heat or open flame.

**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash collection.
