Storage: Store in a cool, dry place.

Disposal: Do not use empty container. Wrap container and put in trash collection.

To Install: Place dispenser 12 feet or more from exposed food. Install at a distance of 7 feet from the floor and where air currents will carry spray throughout room. One unit will treat up to 6,000 cubic feet of air space (a room 30 x 20 x 10) for 30 days, 24 hours a day.

To Operate: Remove protective cap and place can in dispenser. Turn on dispenser. The automatic dispenser will dispense 100 mg. of insecticide every 15 minutes. Its effectiveness will be noticeable one hour after activation.
