



To kill Houseflies, Mosquitoes, Small Flying Moths, Gnats, Black Carpet Beetles, Spiders, Centipedes, Silverfish, Crickets, Firebrats, Bees, Wasps, Hornets and Ants. Aids in the control of Waterbugs and Cockroaches.

#### DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Cover exposed food, dishes, and food-handling equipment. Open cabinets, drawers, and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Unplug or turn off electrical equipment in use area. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Use additional units for remote rooms or where free flow of mist is not assured. Do not remain in the area during treatment and ventilate thoroughly before re-entry. #### TO OPERATE VALVE AS A TOTAL RELEASE SPRAY

To lock value for total activity, hold container upright away from you and point value opening away from face and eyes. Press value button all the way down until it hooks into and catches on bottom of rim. Then place fogger on stand or table in center of room with value locked open, placing several layers of newspaper under can. Follow directions in above paragraph.

To Kill Ticks and Fleas: Destroy pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control product prior to reentry.

To Kill Houseflies, Mosquitoes, Small Flying Moths, Gnats, Wasps, Hornets and Bees: If operated manually do not use as a total release pressurized spray. C'ose all doors and windows. Spray about 5-10 seconds for average room. It is 1 essential to hit flying insects. The airborne mist will kill insects as they fly through it. For Hornets and Wasps double the above dosage. Sweep up and destroy fallen insects. Repeat treatment as necessary.

To Kill Ants, Silverfish, Firebrats, Spiders, Centipedes, Crickets and aid in the control of Cockroaches and Waterbugs: Spray hidden places such as baseboards, crevices, openings around sinks and pipes under cabinets and refrigerators. To kill ants, treat doors, around window frames and ant trails. Spray directly on bugs when possible. Repeat as needed.
