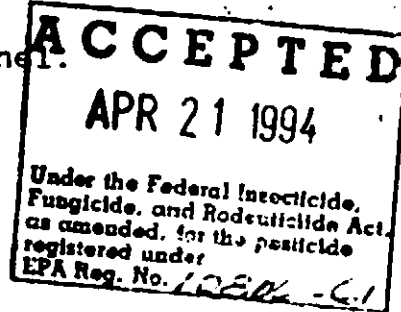
**STATEMENT OF PRACTICAL TREATMENT**

HAZARDS TO HUMANS AND DOMESTIC ANIMALS  
**CAUTION**

May be harmful if swallowed. Avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes and clothing. In case of contact, immediately flush skin and eyes with plenty of water. Wash thoroughly with soap and water after handling. If poisoning occurs, get prompt medical attention.

Do not apply directly to food. Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed. **It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.**

Use Residual Spray from Contact Roach & Ant Killer VI as a spot or crack and crevice treatment to control cockroaches, waterbugs, silverfish, ticks, fleas and other insects listed below. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surfaces until wet. Repeat as needed.

Care should be taken to avoid depositing the product onto exposed surfaces or introducing this product into the air. Avoid contamination of food or food processing surfaces.

**BEST AVAILABLE COPY**

**AS A SPOT TREATMENT TO KILL ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SOWBUGS AND CARPET BEETLES:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators, and cabinets and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever these pests may find entrance. Repeat as necessary.

**TO KILL BROWN DOG TICKS AND FLEAS:** Thoroughly apply as a spot treatment to infested area such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. **DO NOT SPRAY PETS WITH THIS PRODUCT.** Treat your pets with a registered flea and tick product to control the source of infestation.

FOR CRACK AND CREVICE: TO KILL ANTS, COCKROACHES, CRICKETS, SILVERFISH, SOWBUGS, SPIDERS, BROWN DOG TICKS, FLEAS AND CARPET BEETLES: Apply diluted spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases where the above listed insects hide.

FLIES AND MOSQUITOES: Use only out of doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames, as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Flies and mosquitoes coming to rest on treated surface will be killed. Repeat treatment when necessary.

#### STORAGE AND DISPOSAL

DO NOT CONTAMINATE WATER, FOOD OR FEED BY STORAGE OR DISPOSAL.

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not re-use empty container. Replace cap and discard container in trash. Do not puncture or incinerate.
