PRECAUTIONARY STATEMENTS

WARNING

Hazards to Humans and Domestic Animals

Causes skin irritation. Harmful if swallowed. Contains petroleum distillate. Do not induce vomiting because of aspiration hazard. Do not get in eyes, on skin, or on clothing. Do not contaminate food or feedstuffs with this concentrate or dip.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To Kill Fleas, Lice and Ticks: Dilute 2 fluid ounces (4 Tablespoons), with one gallon of water. Dip animal into solution, making sure hair is thoroughly wet to the skin. The area around the ears should be sponged thoroughly. Avoid contact of material with eyes and mouth of animal. Repeat application every two weeks or as necessary.

This concentrate gives long lasting residual control and repellency of fleas and ticks on dogs and cats.

STORAGE AND DISPOSAL

Storage: Store in a cool dry area away from heat or open flame.

Disposal: Securely wrap original container in several layers of newspaper and discard in trash.
