DIRECTIONS

GENERAL: Spray surfaces until wet. Point spray away from people, plants and pets.

INDOOR USE: ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, SAWTOOTHED GRAIN BEETLES (EXPOSED STAGE), WATER BUGS. Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Repeat as needed. Do not spray foodstuffs or houseplants. For ants spray trails and places where ants enter premises. Do not allow children to contact treated surfaces until surfaces are completely dry.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floor. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

OUTDOOR USES: ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, MILLIPEDES, SOWBUGS, and BROWN DOG TICKS: Spray infested areas thoroughly including outside surfaces of screens, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Spray weeds and brushy non-crop areas around the home.

Do not contaminate water by cleaning of equipment or disposal of wastes. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor covering.
