- 4. Provide the pH of the product or the pH at a specified water dilution. If none, report none and explain.
- 5. Add the statement "Do not puncture or incinerate" to the disposal statement.
- 6. Submit a 1-year storage stability study. The formulated product must be analyzed for its active ingredients at time zero and during a year in storage. The storage must be under warehouse conditions of temperature and humidity using containers similar
