**NET WT. 7.5 OZ.**

Cover exposed foods, dishes and food handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Close doors and windows. Point valve opening away from face and eyes when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before reentry.

**TO OPERATE VALVE:** To lock valve in open position for automatic discharge, press valve button all the way down, hooking the catch. Then, place fogger on stand or table in center of room with valve locked open, placing several layers of newspaper or pad under fogger to prevent damage to wood surfaces or floors. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

**TO KILL BROWN DOG TICKS:** Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Do not spray animals. Put fresh bedding in pet quarters after spray has dried. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area.

**TO KILL FLEAS:** Follow directions for ticks, but use one can per 1,500 cubic feet. Aids in control of cockroaches.
