HOW TO USE

SHAKE WELL BEFORE USING. Spray infested surfaces until wet.

To Control: ANTS, PILLBUGS, BOXELDER BUGS, SCORPIONS, CENTIPEDES, SILVERFISH, SPIDERS, COCKROACHES, CRICKETS, EARWIGS, SPIDER BEETLES, WATERBUGS: Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevices, along baseboards, door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Pests flushed out of hiding area should be sprayed directly.

To Control ANTS: Treat ant trails, nests, and points of entry. Repeat treatment as necessary.

To Control BROWN DOG TICKS: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall and floor coverings where localized areas of infestation occur. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH THIS FORMULATION.

To Control CARPET BEETLES, CIGARETTE BEETLES, CLOTHES MOTHS: Spray edges of carpeting and under carpeting, rugs and closets. Make localized application to the floor and baseboards. Spray directly into cracks and crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

To Control FRUIT FLIES, GNATS, HOUSE FLIES, MOSQUITOES, SMALL FLYING MOTHS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures or porches, in garages and other places where these insects alight or congregate.

To control FLEAS indoors: Thoroughly apply as a spray for spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. DO NOT TREAT PETS WITH THIS PRODUCT. To control the source of the flea infestation, pets inhabiting the premises should be treated with a product registered for application to animals.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited.

PESTICIDE DISPOSAL: Pesticide spray mixture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, State and local procedures.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in sanitary landfill, or by other approved State and local procedures.

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

Harmful if swallowed. Avoid contact with eyes, skin and clothing. Avoid breathing vapors or spray mist. Keep away from food, feedstuffs, and domestic water supplies. Wash thoroughly after handling. Do not allow children or pets to contact treated surfaces until spray has dried.

NOTE TO PHYSICIAN: Active ingredients contain a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

Do not spray air in rooms or use on plants.

Apply as a surface spray only as specified on this label.

Do not allow spray to contact food, feedstuffs or water supplies. Thoroughly wash dishes and food handling utensils if contaminated with this product.

Do not use in edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

Remove pets and cover fish bowls before spraying.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching the back of the throat with finger. Repeat until vomit fluid is clear. Call a physician immediately. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply respiration if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.

IF IN EYES: Flush eyes for at least 15 minutes with water. Call a physician immediately.

This product is toxic to fish, birds, and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on label.
