Subject: Labeling Amendments - Maximum Application Rate
Misty weed-A-Cide Concentrate
EPA Reg. No. 10807-146
Misty weed-A-Cide CF
Your submission dated March 6, 2007

The labeling, referred to above, submitted in connection with the application under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable, provided that you make the following changes:

1. Under "Environmental Hazards";
Add "or rinsate" after "washwaters."
2. Under "General Information";
 - Remove "such as" and provide specific locations that these products control.
 - Add the following spray drift control statement:

"Do not allow spray to drift from the application site and contact people, structures people occupy at any time and the associated property, parks and recreation areas, nontarget crops, aquatic and wetland areas, woodlands, pastures, rangelands, or animals. Apply only when wind speed is not more than 10 mph. For sprays, apply largest size droplets possible."
3. Under "Directions for Use";
 - Specify that the annual maximum application rate is 0.23 lb prometon per 500 sq. ft. or 20.04 lbs prometon per acre.
 - For Weed-A-Cide Concentrate, the application rate at 7 pints per 500 sq. ft. has exceeded the maximum application rate. You need to reduce this application rates accordingly. The calculations follow:

The label states that one gallon liquid contains 0.27 lb prometon. An application rate of 7 pints of product per 500 sq. ft. equals to 20.58 lbs



- 6. Add Personal Protective Equipment requirements to Weed-A-Cide Concentrate.
- 7. Under "Storage and Disposal"

Change "Storage" to "Pesticide Storage" for Misty Weed-A-Cide CF.

The amended label supersedes all previously accepted labels. A stamped copy of the revised label is enclosed for your records. Please submit one copy of your final printed labeling before you release the product for shipment.

USE DIRECTIONS: A non-selective herbicide that can be applied for post-emergence or pre-emergence annual and broadleaf weed control. It is recommended that this product be used in areas such as industrial sites (such as cross connects, pedestals, transformers, vaults, buried cable closures, telephone booths and fire plugs), around buildings, storage areas, pumps, machinery, roadways, guard rails, highway medians, rights-of-way, lumber yards, fuel tanks, pipelines, railroads, military installations, fences, recreational areas, residential areas, and airports. Product is water emulsifiable and non-corrosive to equipment.

Do not contaminate water used for domestic or irrigation purposes. Do not store near fertilizers, seeds, insecticides or fungicides.

DILUTION FOR WEED and GRASS CONTROL: SPOT TREATMENT: For control of annual and susceptible perennial weeds (such as downy brome grass, oatgrass, goosegrass, puncture-vine, goldenrod and plantain), thoroughly mix 2-3 pints of this product in 3 gallons of water and spray up to 250 square feet to give thorough and uniform coverage. For hard to kill perennial weeds and grasses, dilute 7 pints in 3 gallons of water and apply to 500 square feet. One application per growing season is usually sufficient to control weed growth; however, a second application may be applied to maintain a weed free soil surface during growth seasons of excessive rainfall.

LARGE TREATMENT AREA: Application rates for large areas depend on climatic conditions, soil type, weeds present and stage of growth of the weeds. Mix one gallon product with 10 gallons water to cover 1000 square feet. The recommended dosages are equivalent to 43-65 gallons of product per acre. For hard to kill perennial weeds and grasses mix 1 ¾ gallons with 10 gallons of water to cover 1000 square feet. One application per growing season is usually sufficient to control weed growth; however, a second application may be applied to maintain a weed free soil surface during growth seasons of excessive rainfall.

The higher rate of application should be used where longer residual control is desired in regions with a long growing season or for control of hard-to-kill perennial weeds and grasses such as Johnson Grass, bindweed and wild carrot. During seasons with excessive rainfall causing heavy weed growth, repeat treatment may be required.

For faster top-kill of existing vegetation, apply this product at the above dilution rates in diesel oil, fuel oil or weed oil. This product should not be used on land to be cropped, or near desirable tree, shrubs or plants, as injury may occur. Do not apply to areas underlaid by roots of desirable trees and shrubs.

WARRANTY STATEMENT: Seller makes no warranty expressed or implied concerning the use of this product other than indicated on the label. Buyer assumes all risk of use and/or handling of this material when use and/or handling is contrary to label instructions.
