The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable, provided you make the following changes before you release the product for shipment.

1. In the PPE section, change "waterproof gloves" to "chemical resistant gloves made of any waterproof material."
2. Under the ingredient statement, specify the pounds of Bromacil and Diuron per pound of product.
3. In the Storage and Disposal section, add a "Pesticide Storage" subheading that includes specific information about the storage of the actual pesticide product.

Submit three (3) copies of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted labels. A stamped copy of labeling is enclosed for your records.

This granular weed killer is a non-selective herbicide for controlling a wide range of annual and perennial weeds and grasses. It is recommended only for non-cropland areas such as railroads rights-of-way and industrial areas. 200-400 pound applications of this product per acre usually results in a non-productive condition of the soil for a period of a year or more. The duration of non-productivity is dependent upon rainfall, soil type and other conditions.

This product should be applied as furnished with a speed spreader, a fertilizer spreader, a shaker type applicator or with any equipment which will distribute the chemical uniformly over the area to be treated. For the control of annual and most perennial weeds and grasses; apply product at the rate of 200-400 pounds per acre; on the smaller plots, 0.5-1.0 pounds per 100 square feet. 400-600 pounds per acre may be required when deep rooted perennial weeds are present. To obtain the best results, this product should be applied to the ground where it will be absorbed by the roots. Applications made early in the season have been found to give results superior to applications at a later seasonal date. Product may, however, be applied at any time of the year. Maximum effectiveness in arid regions is obtained when application is made just prior to the rainy season. Users should consult state agricultural experiment stations or extension service weed specialists for recommendations as to use in their particular area. Do not apply more than 600 lbs. of product per year.

**STORAGE AND DISPOSAL:** Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product must be disposed of according to applicable Federal, state or local procedures. **CONTAINER DISPOSAL:** IF EMPTY: Do not reuse this container.
