The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. A stamped copy of your label is enclosed for your records. Please correct the following typographical error in the final printed labeling:

Under Precautions and Restrictions, change "or" to "of" in the third-to-last statement so that it reads "Do not contaminate water by cleaning of equipment or disposal of wastes."

This label supersedes all previously accepted labels for the subject product. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after eighteen (18) months from the date of this letter or the next printing of the label, whichever occurs first, must bear the new, revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PRECAUTIONS AND RESTRICTIONS: Do not apply this product in a way that will contact workers or other persons, either directly or through drift. APPLICATION INSTRUCTIONS (Site Specific):

NON-CROP OR NON-PLANTED AREA USES: To kill above ground weed growth around buildings and other installations, ornamental gardens, walkways, patios, beneath greenhouse benches, fence lines, golf courses, parkways and driveways for control of undesirable broadleaved and grassy weeds - 1 gal. per 20 gal. of water (6 1/2 oz. per gal. water). Apply for full coverage and thorough weed contact. Apply preferably to young growth and up to seeding of weeds. Repeat applications necessary to maintain control, particularly on grasses and established weeds. Avoid spray contact with foliage or food crops or ornamental plants. Do not water treated areas for 24 to 36 hours after application.

AQUATIC USE DIRECTIONS: For application only to still water (i.e., ponds, lakes, and drainage ditches) where there is little or no outflow of water. Do not use the treated water for animal consumption, spraying, irrigation, or domestic purposes for 5 days after treatment.

Treatment of dense weed areas can result in oxygen loss from decomposition of dead weeds. This loss may cause fish suffocation. Therefore, treat only 1/3 to 1/2 of the water body area at one time, especially if dense areas of weeds and/or algae exist, and wait 14 days between treatments. Consult your State Fish and Game Agencies before applying this product to public waters. **DO NOT APPLY TO MUDDY WATER.** Avoid creating muddy water during application. Do not apply under conditions of high wind and wave action. Do not apply where plants are covered with mud deposits.

APPLICATION FOR SUBMERGED WEEDS: In early season where submersed weed growth has not reached the surface apply this product by pouring directly from the container into the water while moving slowly over the water surface in a boat. Distribute evenly over infested areas in strips 40 feet apart. In mixed weed populations, use the high rate of application as indicated by weeds present. In late season or where submersed weed growth has reached the water surface throughout the area to be treated apply this product by pouring as above or injecting a diluted (10-20 to 1) solution below the water surface in strips no more than 20 feet apart. Use the high rate of application as indicated by the weeds present. Where

algae are present along with the submerged weeds, pre-treatment with Copper Sulfate at recommended rates is advised for best results with this product.

APPLICATION FOR FLOATING WEEDS: 150 to 200 gallons of water plus a non-ionic surfactant* should be applied as an overall spray for control of the above weeds. The high rates of this product should be used for late season application.

*Add a Nonionic Surfactant containing 75% or greater surface active agent at the rate of 1/2 to 4 pints per 100 gallons of finished product.

Duckweed (*Lemna spp.*)
APPLICATION FOR DUCKWEED: For control, apply this product as an all-over spray in 50 to 150 gallons of water per acre. Care should be taken to thoroughly cover all plants on water and on damp marginal areas. Reinfestation of duckweed occurs readily from untreated areas. Retreatment of this product may be necessary to obtain season long control.

MARGINAL WEEDS

(Infesting the Edges and Other Portions of Ponds, Lakes, and Ditches):
Cattails (*Typha spp.*)
APPLICATION FOR MARGINAL WEEDS: For top kill, apply this product in 100 gallons of water plus a non-ionic surfactant* for full coverage and thorough weed control. Repeat treatment as necessary to control re-growth. For best results apply before flowering.

*Add a Nonionic Surfactant containing 75% or greater surface active agent at the rate of 1/2 to 4 pints per 100 gallons of finished product.

APPLICATION FOR ALGAE: This product will control certain filamentous algae: Spirogyra spp. and Pithophora spp. Apply 0.5-1.5 ppm with product for control. Application methods as for submerged weeds.

Formula for Parts Per Million (ppm) Recommendations: Gallons to use - ppm recommended x acreage of water x average depth of water x 14. (Example: 1/2 ppm recommendations; two acre pond; 4 feet average depth; 1/2 x 2 x 4 x 14 = 56 gallons required.)
