The labeling, referred to above, submitted in connection with the application under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provide you make the following changes:

1. Under "Weight Statement";

Add the following active ingredient (AI) weight statement:  
"This product contains 0.XX lb. of Prometon per gallon."

2. Under "First Aid";

Add the following statements:  
If swallowed:

- Call poison control center or doctor immediately for treatment advice.
- Do not induce vomiting unless told to do so by the poison control center or doctor.
- Do not give anything by mouth to an unconscious person.
- Do not give any liquid to the person.

If inhaled:

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, than give artificial respiration, preferably by mouth-to-mouth if possible.
- Call a poison center or doctor for further treatment advice.

3. "Under Directions for Use";

Use the one gallon size container for all applications and make changes for the following applications:


- Where vegetation is tall and dense, use one gallon of this product in ten gallons of water per 830 sq. ft. of soil surface.

- For control of . . . and wild carrot, use one gallon product per 280 to 420 sq. ft. of soil surface.
