FOR USE IN Food service and preparation areas, food processing plants, restaurants, clubs, stores, supermarkets, bottling plants, warehouses, buildings, factories, offices, laboratories, lavatories, ships, planes (cargo areas), hotels, motels, hospitals, nursing homes, schools, day-care centers, funeral homes, kennels, farms, barns, stables, dairies, homes, milk and egg handling areas of dairies and chicken houses.

This product is engineered for use in automatic metered dispensers. The dispenser automatically activates the special metered valve every 15 and/or 30 and/or 45 minutes. Within 24 hours the area is relatively free of house flies, mosquitoes, gnats, and small flying moths and with continued use reduces annoyance from them. Effectiveness of this product will be noticeable within one hour after the Dispenser is activated. Recommended use is for 24 hours: but if less than 24 hour use is required, the Dispenser should be set to start one hour before kill is desired and run one hour after kill is no longer needed. Factors such as airflow rate, size of space treated, humidity and room temperature affect insect activity and kill. Therefore, one unit per 6000 cubic feet of unobstructed space should be considered as an average with adjustments made depending on specific conditions at usage site. As with any method of insect kill, best results are achieved when sanitation and other positive insect prevention practices are followed. Do not use in aircraft cabins. It is suggested that the container be changed once a month.

OPERATION: Remove protective cap from top of can and insert can in dispenser. Suspend dispenser 7 feet from floor and at a point where wind flow will carry the particles throughout the room. **OUTDOORS:** this product can be used to treat dog kennels, dog runs, side yards, patios, decks & [and] residential landscapes. Set the dispenser to treat at dawn & [and] dusk & [and] use when humans are not in the area. When heavy pest infestations are present the dispenser may be set to treat at [15], [30], [45], [15] [30] [45] [15-45] minute intervals. Place the dispensers out of the reach of pets & [and] children & [and] use the prevailing wind to assist in carrying the spray throughout the area to be treated. This product can be used to kill Mosquitoes, [including Culex species] [which may carry] [the West Nile Virus]. [This product can be used to kill House Flies, Mosquitoes, Gnats & Small Flying Moths.] Each dispenser will treat up to 650 square feet. Use enough dispensers to treat the entire area you want protected.

[OPERATION: Remove protective cap from top of can & [and] insert can in dispenser. Secure dispenser at least 7 feet from floor or ground & [and] at a point where air flow or wind will carry the particles throughout the area to be protected.]

STORAGE AND DISPOSAL: Do not contaminate water, food or feed by storage or disposal.
