

DIRECTIONS FOR USE:

ROACHES AND ANTS. Use 3 to 4 ounces for each 100 sq. ft. of area. Using equipment to give a coarse wet spray. For roaches and ants, treat doors, around window frames, base boards, and pipe openings. For silverfish, use 3 to 4 oz. per 100 sq. ft. Frequent spraying of base boards, door frames, book cases and storage areas are necessary. Repeat treatment as necessary.

FLIES, MOSQUITOES, GNATS: Use 1/2 oz. per 1000 cu. ft. of space, directing the spray toward ceiling. Keep sprayer in constant motion, at least 36 inches away from walls, fabrics, furniture, floors, plastics, etc. Spraying closer may cause stains. Most asphalt tile, some linoleum and certain plastic materials have a tendency to discolor and soften when wet with petroleum base insecticides. Before spraying, test such materials by applying to small inconspicuous area.

FILL THE ROOM WITH MIST. SWEEP UP AND DESTROY FALLEN INSECTS. REPEAT TREATMENT WHEN NECESSARY.

CLOTHES MOTHS: Use 1 to 2 oz. per 1000 cu. ft. of space. When spraying clothes in storage for adult moths, separate clothing. For the larvae, pay particular attention to seams and folds of garments. Clothing should be sprayed individually. For storing clothing in chests, first treat as above, and also spray storage container before packing. Repeated monthly applications are advisable.

BEDBUGS: Use 1 to 2 oz. per 1000 cu. ft. of space. Spraying mouldings, baseboards and cracks. Also spray bedstead, paying particular attention to cracks and crevices. Spray springs and mattresses as well.

FOOD PROCESSING ESTABLISHMENTS: Exposed edible products must be removed or covered before spraying is begun and the premises must be cleaned thoroughly by washing after spraying is completed. Spray only when facility is not in operation.

Pay particular attention to cracks, crevices and other hiding places. Repeat treatment as required.

DO NOT REMAIN IN TREATED AREAS. VENTILATE THE AREA AFTER TREATMENT IS COMPLETED.

Sanitation is necessary. Clean and remove deposits of food, grain and dust from storage areas. Clean conveyors and handling equipment.
