

PRECAUTIONARY STATEMENTS

CAUTION

Use undiluted in and around buildings. Apply with a low-pressure sprayer equipped with a coarse spray nozzle. Spray surfaces only until wet. Avoid excessive run-off. Apply to all insect breeding sites and harborage. Not to be used as a mosquito larvicide. Also treat adjacent exposed surfaces where insects may crawl when they come out of hiding. Repeat treatment as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container. **PESTICIDE DISPOSAL**—Pesticide, spray mixture or rinseate that cannot be used should be disposed of according to procedures approved by Federal, State or Local disposal authorities.

COCKROACHES—Thoroughly treat the infested area behind, cracks and crevices; around window and door surfaces of shelves, drawers and work tables; behind cabinets, refrigerators, sinks and stoves; in and around tainers, switch panels, junction boxes and floor drains.

ANTS—Apply to trails and places where ants enter, and door frames, spray hills and runways outdoors.

CADELLES, CIGARETTE BEETLES, DRUGSTORE BEETLE, MEAL MOTHS, MEDITERRANEAN FLOUR MOTH, RED FLEA SAWTOOTHED GRAIN BEETLES (EXPOSED STAGES)—Thoroughly spray the floors and walls of the infested area with attention to corners and perimeters. Sanitation and dust control are of importance. Fumigate or destroy infested products.

SILVERFISH, FIREBRATS AND PAPERLICE—Apply to areas infested by these insects.

BROWN DOG TICKS—Spray sleeping quarters of pets, boards, window and door frames, wall cracks and floors. Repeat as needed. Fresh bedding should be placed in quarters after spraying of pet area. Do not spray animals.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SCORPIONS AND SPIDERS—Thoroughly spray the exterior perimeter of the infested premises. For Crickets give special attention to window frames.

FLEAS, FLIES, GNATS, MOSQUITOS, PUNKIES AND SPIDERS (Outdoors only)—Spray infested areas thoroughly, including side surfaces of screens, doors, window frames, foun and other areas where insects may enter.

FOOD HANDLING ESTABLISHMENTS—NON FOOD AREAS FOR CONTROLLING ANTS, ROACHES, WATER BUGS, CRICKETS, SILVERFISH, AND SPIDERS.

NON FOOD AREAS—Include bedrooms, lavatories, bathrooms, offices, locker rooms, boiler rooms, garages, closets and storage areas (or basements). ANTS—Apply to trails and places where ants enter, such as window and door frames, spray hills and runways outdoors.

CADELLES, CIGARETTE BEETLES, DRUGSTORE BEETLES, INDIAN MEAL MOTHS, MEDITERRANEAN FLOUR MOTH, RED FLOUR BEETLES, SAWTOOTHED GRAIN BEETLES (EXPOSED STAGES)—Thoroughly treat floors and walls of the infested area with attention to cracks, crevices, corners and perimeters. Sanitation and dust control are of primary importance. Fumigate or destroy infested products.

SILVERFISH, FIREBRATS AND PAPERLICE—Apply to localized areas infested by these insects.

BROWN DOG TICKS—Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as needed. Fresh bedding should be placed in animals quarters after spraying of pet area. Do not spray animals.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SOWBUGS, SCORPIONS AND SPIDERS—Thoroughly spray the interior and exterior perimeter of the infested premises. For CLOVER MITES, give special attention to window frames.

FLEAS, FLIES, GNATS, MOSQUITOS, PUNKIES AND SANDFLIES—(Outdoors only)—Spray infested areas thoroughly, including outside surfaces of screens, doors, window frames, foundations, patios and other areas where insects may enter.

FOOD HANDLING ESTABLISHMENTS—NON FOOD AREAS FOR CONTROLLING ANTS, ROACHES, FLIES, WATER BUGS, CRICKETS, SILVERFISH AND SPIDERS.

NON FOOD AREAS—Include storage rooms, lavatories, floor drains, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).
