

Directions for use in industrial cooling tower water

Gamacide 1831, a fungal and algae slimicide for industrial recirculating cooling tower water may be added as a slug or continuous treatment. Add where agitation is sufficient directly to the system being treated and separately from other chemical additives.

CONTAINER DISPOSAL

Wash contaminated clothing before reuse. If swallowed, induce vomiting by sticking finger down the throat or by giving an emetic such as 2 tablespoonfuls of salt in a glass of warm water.
