APPLICATION

BAF-TROL is a specially prepared product for controlling algae, bacteria, and fungus in industrial and commercial recirculating water cooling towers, evaporative condensers and air washers. Prior to its use in air washers, the system should be precleaned, if dirty, by applying a suitable detergent solution to the air washer tank. Let system run 2 hours with fan off. Dump and flush tank. Check all nozzles. Remove plugged nozzles and clean manually. Air washer waters subject to acidification from tobacco dust or other acidifying materials require periodic adjustment of pH with alkaline additives.

COOLING TOWERS & EVAPORATIVE CONDENSERS — Initial Dose: When the system is noticeably fouled, apply 1 to 1½ quarts of BAF-TROL per 1,000 gallons of water in the system. Repeat until control is achieved. Subsequent Dose: When microbial control is evident, add 1 to 2 pints of BAF-TROL per 1,000 gallons of water in the system every 4 to 7 days or as needed. Heavy contaminations of slime or scale must be removed manually.

AIR WASHERS — Initial Dose: When the system is noticeably fouled, apply ¾ to 1¼ quarts of BAF-TROL per 1,000 gallons of water in the system. Repeat until control is achieved. Subsequent Dose: When microbial control is evident, add 1/3 to 1 pint of BAF-TROL per 1,000 gallons of water in the system, every 3 days or as needed.

Heavy contaminations of slime or scale must be removed manually. BAF-TROL may be added in the tower sump, tower basin or on distribution decks.

CAUTION

KEEP OUT OF THE REACH OF CHILDREN

Harmful if swallowed. Avoid contact with skin and eyes. Wear goggles or face shield and rubber gloves when handling. May cause severe eye damage and skin irritation.
