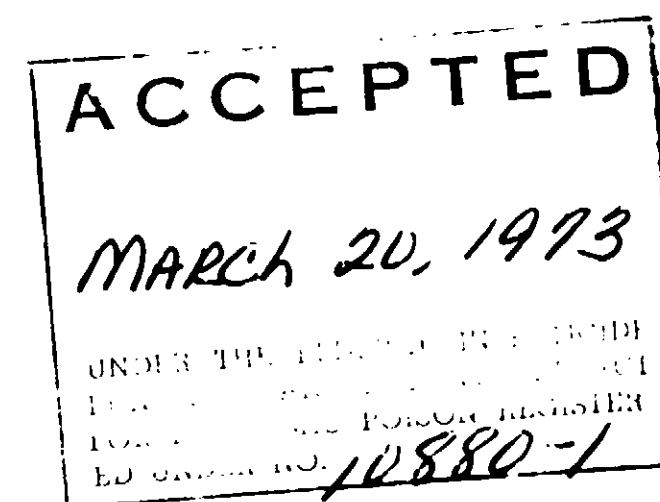


MARCIDE 105

DIRECTIONS FOR USE

Prior to the application of MARCIDE 105 to the cooling tower, any encrustations or deposits should be removed by hosing or scraping. When treating a multi-cell tower, one cell may be sprayed by stopping the fan for that cell.

The fungicide may be sprayed directly on the wood without dilution or may be diluted to a 30-50% solution. Experience indicates that 1½ to 2 drums of MARCIDE 105 is sufficient to spray on average tower cell with approximate dimensions of 55 feet square at the bottom, 75 square at the top, and 50 feet in height.
