Employ the following table, when adding new or distilled solvent, to maintain the required 1/2% CHARGE.

5 Gals. Solvent	4 Fluid Oz.
10 Gals. Solvent	7 Fluid Oz.
20 Gals. Solvent	13 Fluid Oz.

50 Gals. Solvent	32 Fluid oz.
