

Dear Mr. Johnson:

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable with conditions.

- Change primary brand name to "Hasa Jumbo Swimming Pool • Chlorinating Tablets".
- Update the Storage and Disposal for Pesticides Containers and . Containment
- Add subheadings, instructions for estimating pools size and updated instructions under the Swimming Pool Water section.
- A copy of the Confidential Statement Formula to be added to the file.

### **Conditions:**

The residual removal language on the proposed label applies rigid non-1. refillable containers that are to large to shake (i.e., with capacities greater that 5 gallons or 50 lbs. Therefore, your reference to containers 2.2 or more pounds has been removed.

Clarify the Superchlorination and New Pool or Spring Start Up 2. directions for use to indicate the actual dosage amount necessary to shock the swimming pool. For example it takes 2 tablets per 10,000 gallons of water to maintain the pool. Based on those calculations it would require a minimum of 6 tablets per 10,000 to super chlorinate the swimming pool.

#### **General Comments:**

A stamped copy of the labeling accepted with conditions is enclosed. Submit one copy of your final printed labeling before distributing or selling the product bearing the revised labeling.

The primary brand name of this product will be changed from "Tabit 100 Chlorinating Tablets" to "Hasa Jumbo Swimming Pool Chlorinating Tablets."

The proposed basic CSF, dated October 12, 2009, will be made a part of the file for this product.



Repeat this procedure two more times.

**Pressure Rinse:** Pressure rinse as follows: Empty the remaining contents into application equipment or mix tank. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow begins to drip.

### SWIMMING POOL WATER DISINFECTION

GENERAL INSTRUCTIONS AND INFORMATION – These tablets are manufactured for use in erosion type feeders, wherein they are slowly dissolved as the water flows over the tablets to control algae growth, kill bacteria, and destroy organic contaminants in the swimming pool. Do not throw the tablets directly into the water. Contact with concrete or vinyl walls may result in staining.

**NEW POOL OR SPRING START UP** – Using a suitable test kit, adjust total alkalinity to 80 - 150 ppm and pH to 7.2 - 7.8. Superchlorinate (Shock) the pool with an appropriate product to obtain an available chlorine residual of 5 - 10 ppm. Follow superchlorination or "shock" directions on the label of the selected product. Use pool when the available chlorine residual is in the 1-4 ppm range and the pH is between 7.2-7.8. Entry into treated pools is prohibited above levels of 4 ppm due to risk of bodily harm.

**TESTING** – Use a reliable test kit with fresh solutions to determine pH, available chloring residual, and alkalinity levels. Ideal swimming conditions are pH between 7.2 and 7.8, available chlorine residual between 1 and 4 ppm and a total alkalinity between 80 and 150 ppm.

**MAINTENANCE** – If the directions for use supplied with the chlorinator are missing or unclear, try 2 tablets per 10,000 gallons each 7-10 days. Twenty-four hours after filling the tablet feeder, check the available chlorine with a test kit. If necessary, adjust the feed rate so that the chlorine residual is maintained between 1 - 4 ppm. If you are unable to maintain a residual after three days, superchlorinate the pool. Disconnect or remove feeder. superchlorinate and reconnect feeder when residual is below 4 ppm. Readjust feed rate to maintain a 1 - 4 ppm residual. One tablet will provide 5.25 ppm available chlorine per 10,000 gallons of pool water.

SUPER-CHLORINATION - Superchlorination, the addition of several times the normal amount of chlorinating chemical, is necessary to establish an initial chlorine residual in a freshly filled pool, every 7-10 days during the swimming season and after special problems, such as heavy swimming use, dust and wind storms, rain and unusually hot weather. A fast dissolving granular or liquid chlorinating product should be used. Follow superchiomation on the label of the selected product. Re-entry into treated pools is prohibited above levels of 4 ppm due to risk of bodily harm.
