

PRECAUTIONARY STATEMENTS

Hazards to humans and domestic animals:

**DAANGER!**

Corrosive, may cause severe skin irritation or chemical burns to broken skin. Causes eye damage. May be fatal if swallowed. Avoid breathing vapors. Do not get in eyes, on skin, or on clothing.
