# 00882 Spray Disinfectant

00882 Spray Disinfectant is designed for use in Homes, Nursing Homes, Hospitals, Institutions, Offices, Schools, Motels and Hotels.

When used as directed, 00882 Spray Disinfectant is formulated to disinfect inanimate hard surfaces (such as walls, desk tops, sink tops, telephones, door knobs, diaper pails, toilet seats, bed pans and hampers).

In addition, 00882 Spray Disinfectant deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, rest rooms, shower stalls and other areas which are prone to odors caused by microorganisms.

When used as directed, 00882 Spray Disinfectant demonstrates effective disinfection against *Staphylococcus aureus*, *Salmonella choleraesuis*, and *Pseudomonas aeruginosa* and *Trichophyton mentagrophytes*.

The product is fungicidal against Pathogenic Fungi (Athletes Foot Fungus), when used as directed on hard surfaces found in the bathroom, shower stalls and locker room, or other clean, hard, non-porous surfaces commonly contacted by bare feet.

**MOLD AND MILDEWSTAT** - 00882 spray Disinfectant prevents and controls mold and mildew and the odors they cause on hard non-porous inanimate surfaces when used as directed.

**Directions:**  
It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

## SURFACE DISINFECTION AND DEODORIZATION:

- First remove soil deposits from surface to be treated
- Hold can six inches from surface and spray until completely wet, allowing the surface to remain wet for 10 minutes.

## AIR DEODORIZER AND AIR REFRESHER:

- Point spray upwards to center of room and spray for three seconds.

**MILDEWSTAT** - To control mold and mildew on hard non-porous surfaces (such as floors, walls, table tops), spray the surfaces to be treated. Make sure to wet completely. Let air dry. Repeat application at weekly intervals or when mildew growth reappears.

**Precautionary Statements - Hazards to Humans & Domestic Animals**  
**WARNING! KEEP OUT OF REACH OF CHILDREN.** Causes eye and skin irritation. Do not get in eyes, skin or on clothing - Harmful if swallowed  
**STORAGE AND DISPOSAL** - Do not contaminate water, food or feed by storage disposal. Open dumping is prohibited. Do not reuse empty container.  
**DISPOSAL** - Do not reuse empty container. Wrap container and put in trash collection.  
**STATEMENT OF PRACTICAL TREATMENT:** In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash all contaminated clothing before reuse. If swallowed, drink egg whites, gelatin solution or if these are not available, drink large quantities of water. Call a physician.  
**NOTE TO PHYSICIAN:** Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.
