



Directions For Use: Read and follow all directions and precautions on this product label. Do not apply over cuts, wounds, or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid over-application of this product. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again. Use of this product may cause skin reactions in rare cases. If you suspect a reaction to this product, discontinue use, wash treated skin, and call your local poison control center. If you go to a doctor, take this product with you. Do not spray in enclosed areas. If used on the face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face. It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To repel the insects listed on the front panel, first remove protective cap. Hold can at least 12 inches away, point valve in desired direction and press button to spray. Do not spray in enclosed areas. Apply to exposed skin areas. Do not apply over cuts, wounds, or irritated skin. Do not apply to eyes and mouth and do not apply to hands of young children. Do not spray directly on face. To apply to face, spray on hands and rub on. Use just enough repellent to cover exposed skin and/or clothing.

Do not use under clothing. Avoid over-exposure. Frequent reapplication and saturation is unnecessary for effectiveness. Repeat as needed. For ticks and chiggers, also apply to shoe tops, socks and around openings in clothing. After returning indoors, wash treated skin with soap and water. Wash treated clothing.

Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent with you.

Avoid contact with plastics, such as eyeglass frames, and such fabric as acetate rayon.

FIRST AID

- -Call a poison control center or doctor for further treatment advice.
