Dear Mr. Zajac;

The Agency in accordance with the Federal Fungicide and Rodenticide Act as Amended (FIFRA) has completed reviewing all of the information submitted with your application to support the reregistration of the aforementioned product in connection the **DEET RED**, and have concluded that your submission is acceptable with the following label revision provisions:

1. Page 1:

a. Ingredient Statement:

- i. Revise the ingredient statement to include the other isomers within the DEET expression: "DEET.....25.00%."

2. Page 2:

a. Directions for Use

- i. Remove the statement "Do not apply more than 3 times per day to children ages twelve (12) and under."
- ii. Replace all instances of the statement "Avoid overexposure." With "Avoid over-application of this product."
- iii. Within the first paragraph, replace the statements "Do not spray directly onto face. Spray hands first and then use hands to wipe spray onto face." With: "If used on the face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face."
- iv. Within the second paragraph, replace the statements "Do not spray directly on face. To apply to face, spray on hands and rub on." With "If used on the face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face."
- v. Within the third paragraph, remove the following sentences "Frequent reapplication and saturation is unnecessary for effectiveness. Repeat as needed."
- vi. Within the fourth paragraph, replace the sentence "Wash treated clothing." With "Wash treated clothing before wearing it again."

b. Precautionary Statement

- i. Replace the Precautionary Statement with the following text:  
**"HAZARDS TO HUMANS**  
**CAUTION:** Harmful if swallowed. Causes moderate eye irritation. Avoid contact with eyes. Wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet."
  - c. Environmental Hazards Statement
    - i. This section may be removed from the label.
- 3. Page 3:
  - a. First Aid Section
    - i. Replace the section:
      - "IF ON SKIN OR ON CLOTHING
      - If you suspect a reaction to this product:
      - Discontinue use.
      - Rinse skin immediately with plenty of water for 15-20 minutes.
      - Call a poison control center or doctor for treatment advice."
    - With the following:  
 If you suspect a reaction to this product, discontinue use, wash treated skin, and call your local poison control center. If you go to a doctor, take this product with you."
  - b. STORAGE AND DISPOSAL:
    - i. Replace the STORAGE AND DISPOSAL section with the following text:
      - "STORAGE AND DISPOSAL
      - Do not puncture or incinerate!
      - Pesticide Storage:** Store in a cool, dry area away from heat or open flame.
      - Pesticide Disposal:**
      - If Partially Filled:** Call your local solid waste agency or [toll free number]<sup>1</sup> for disposal instructions.
      - If Empty:** Place in trash or offer for recycling if available."
  - c. Warranty and Disclaimer Statement
    - The Warranty and Disclaimer statement must be revised to comply with the Agency's *Guidance on Warranty Statements* published October 17, 2006. A copy is available at the following internet site:

    - Otherwise, you may remove the Warranty and Disposal Statement from the label.
    - Either of the following revisions must be submitted as an amendment for Agency approval.

A toll-free telephone number must appear on all product labels for consumers to call for additional product information and to report incidents.

Current labels on DEET repellent products tend to dissolve from contact with the repellent (usually liquids). All reregistered DEET product labels must use materials that remain permanent and readable for the reasonable life of the product. The Agency determined in the DEET RED document that all aerosol and pump spray formulations must be packaged in containers utilizing a concave trigger to help aim product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.


