The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made to the label:

1. Line up the decimal points in the list of ingredients on page 1.
2. On page 5 in the first paragraph in the box change "...if overhead exposure, protective." to "...if overhead exposure, and protective eyewear."

You must submit documentation annually to verify that this product is currently listed by the Organic Materials Review Institute (OMRI) for use in production of organic food and fiber when the listing with OMRI is renewed.

**APPLICATION RATE:**

**GRAPES:** Powdery mildew, Bunch Rots - Use 20 lbs. per acre. Apply when berries start to touch and thereafter as needed. Britz Copper Sulfur 15-25 Dust must be applied before the disease appears. Allow at least 3 days between applications. Do not apply more than 133 pounds per acre per year.
