DORMANT SPRAY is an excellent early spring "Clean-up" and dormant spray for **CITRUS** and many other **FRUIT** and **SHADE TREES** including, **EVERGREEN AND DECIDUOUS SHRUBS** and **GARDEN PLANTS** such as **CAMELLIAS, AZALEAS, GARDENIAS, HIBISCUS, HOLLY, VIBURNUM, PRIVET** and **ROSES** (after pruning). Dormant Spray controls Scale insects (**Carmella, Rose, San Jose, Black, Red**) in migratory state, **MEALY BUGS, RED SPIDER MITES** and **PEACH LEAF CURL**.

APPLICATION

Apply through hose end spray or, tank pressure or trombone sprayer. Shake well before using. Partially fill sprayer with water and add insecticide under agitation. Add balance of water.

Apply using a coarse spray with considerable force. Thoroughly cover branches and trunk spraying to the point of runoff. Always prepare a fresh spray solution at time of use.

Do not apply through any type of irrigation systems.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DO NOT APPLY IN SPRING AFTER BUDS BEGIN SHOWING NEW GROWTH. USE ONLY WHEN PLANTS ARE DECIDUOUS OR DORMANT. Shake well before using.

ROSES, DECIDUOUS ORNAMENTALS, SHADE AND FRUIT TREES: Prune and destroy all old leaves and branches. Mix 8 tablespoons in one gallon of water (one pint in 4 gallons of water).

PEACHES: Peach leaf curl - Spray in spring before buds begin to swell and in fall before seasonal rains. Rainfall immediately after spraying necessitates respraying. Mix 8 tablespoons in one gallon of water (one pint in 4 gallons of water).
