



Under normal soil fumigation conditions, the concentration of methyl bromide in the working area will not generally exceed 5 ppm es a time-weighted average and no respiratory protection is required. However, there is the possibility of a spill or leak during soil fumigation. Therefore, a SCBA or combination air-supplied/SCBA respirator must be available and will be required for entry into an affected area in the event of a leak or spill.

#### CLOTHING PRECAUTIONS



Work upwind if possible. Allow spill to evaporate. This is most likely to occur when heavy rates of fertilizer and fumigant are applied to soils that are either cold, wet, acid, or high in organic matter. To avoid injury to plant roots, fertilize as indicated by soil tests made after fumigation. To avoid ammonia injury and/or nitrate starvation to crops, avoid using fertilizers containing ammonium salts and use only fertilizers containing nitrates until after the crop is well established and the soil temperature is above 65 degrees P. Liming highly acid soils before fumigation stimulates nitri-fication and reduces the possibility of ammonia toxicity.
