**DIRECTIONS FOR USE**

Nearly fill spray tank, then pour in specified amount of product. Add balance of water to fill tank. Do not combine with wettable powders.

**REGULAR MIXTURE** Use 1 quart per 100 gallons of water, 1 pint per 50 gallons of water, 8 ounces per 25 gallons of water, 4 ounces per 12.5 gallons of water or 1 tablespoon per 1.5 gallons of water except where otherwise stated in directions.

**FLOWER, SHRUB, AND ORNAMENTAL TREE PESTS** For Grasshoppers, Wasps, and Spiders, spray plants thoroughly with regular mixture.

**LAWN PESTS** For Ants, Sod Webworms, Fall Armyworms, Crickets, Mole Crickets, Scorpions, Fleas, Chiggers, Wood Ticks, Sow Bugs, spray regular mixture at the rate of 1 gallon per 100 square feet. Do not water lawn for several days afterwards.

**RED ANTS OR FIRE ANTS**, nesting in non-crop land or non-pasture areas, specifically lawns, cemeteries, right-of-ways or vacant lots, pour 1 pint to 2 quarts of mixture in hole of ant nest.

**SUBTERRANEAN TERMITES** Use in a 2% water emulsion obtained by mixing at the rate of 5 tablespoons per gallon of water as follows: For buildings having basement or crawl spaces, dig a trench along the outside of the foundation walls. In brick or hollow block or concrete foundations, dig a trench to, but not below, the footings. Then as the trench is refilled, treat the soil at the rate of 4 gallons per 10 linear feet for each foot of depth. A trench 3 feet deep would require 12 gallons per linear feet.

The objective is to establish a treated soil barrier which will prevent termite entry. Other critical areas may also require treatment. It is suggested that you consult the State Extension Service for advice.

**WARNING: Avoid breathing spraymist and skin contact. Harmful if swallowed.** In case of contact with skin, wash with soap and water. Avoid contamination of food and foodstuffs. Keep out of reach of children. Keep children and pets off treated lawns until insecticide is washed into soil and grass is completely dry. Do not use on human or cats.

This product is toxic to fish, birds and other wildlife. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not apply when weather conditions favor drift from areas treated. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

**ANTIDOTE:**

External - In case of spillage on skin, wash promptly with soap and water.  
Internal - Emetic of 1 tablespoon of mustard in tumbler of water. Call a physician.
