This is in response to the subject amendment. The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable subject to the following comments.

Revise the Statement of Practical Treatment to read as follows:

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Drink promptly a large quantity of water. Do not induce vomiting. Avoid alcohol. Get medical attention.

If In Eyes: Flush with plenty of water for 15 minutes. Get medical attention.

If On Skin: Wash with plenty of soap and water. Get medical attention if irritation persists.

NOTE TO PHYSICIAN

Probable mucosal damage may contraindicate the use of gastric lavage.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Directions

When starting up a new pool, superchlorinate to satisfy chlorine demand and to establish a chlorine residual of 1.0 ppm to 1.5 ppm available chlorine. To accomplish this add 1 oz. Leslie's Chlor Brite II per 1,000 gallons of pool water. It is necessary to condition pool water with Leslie's Conditioner according to directions on box.

Leslie's Chlor Brite II should be added every other day or as needed, at the rate of 2 ozs. per 10,000 gallons of pool water to maintain a chlorine residual at all times of 1.0 ppm to 1.5 ppm as determined by a suitable test kit. The pH should be maintained between 7.4 and 7.6.

Keep in mind that a slight flexibility must be maintained in the event of heavy accumulations of dust and dirt caused by storms or super heavy bathing loads. These require additional dosages to maintain the chlorine residual between 1.0 ppm and 1.5 ppm, as determined by a LESLIE's MARK IV TEST KIT.

PRECAUTIONARY STATEMENTS

Hazards to Humans And Domestic Animals

DANGER: Highly corrosive. Causes skin and eye damage. May be fatal if swallowed. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Irritating to nose and throat. Avoid breathing dust. Remove and wash contaminated clothing before reuse.

Environmental Hazards

This product is toxic to fish. Do not discharge into lakes, streams, ponds, or public waters unless in accordance with an NPDES Permit. For guidance, contact the regional office of EPA.

Physical and Chemical Hazards

STRONG OXIDIZING AGENT: Strong Oxidizing Agent. Mix only with water. Use clean, dry utensils. Do not add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. CONTAMINATION WITH MOISTURE, ACIDS, ORGANIC MATTER, OTHER CHEMICALS OR EASILY COMBUSTIBLE MATERIALS SUCH AS PETROLEUM OR PAINT PRODUCTS MAY START A CHEMICAL REACTION WITH GENERATION OF HEAT, LIBERATION OF HAZARDOUS GASES AND POSSIBLE GENERATION OF A FIRE OR EXPLOSION. In case of contamination or decomposition, do not reseal container. If possible, isolate container in open air or well ventilated area. Flood with large volumes of water, if necessary.

IF SWALLOWED: ~~feed bread soaked in milk followed by olive oil or cooking oil.~~ Call a physician immediately.

IF ON SKIN: Brush off excess chemical and flush skin with cold water for at least 15 minutes. If irritation persists get medical attention.

IF IN EYES: Flush with cold water for at least 15 minutes. Get medical attention.

Storage and Disposal

Securely wrap original container in several layers of newspaper and discard in trash. Do not reuse container. Rinse thoroughly before discarding in trash. Keep this product dry in a tightly closed container, when not in use. Store in a cool, dry, well ventilated area away from heat or open flame. In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all materials before discarding this container. Do not reuse empty container but place in trash collection. Do not contaminate food or feed by storage or disposal, or cleaning of equipment.
