For maximum effectiveness, pools, spas, whirlpools, hot tubs, decorative fountains and containerized ponds containing heavy growth of algae should be cleaned prior to using this product.

ROUTINE USE: For pools having just visible algae growth add an initial dose of 11 to 16 fluid ounces of Leslie's Swimming Pool Supplies Algae Control per 10,000 gallons of water and remove settled algae. For treatment of freshly cleaned and filled pools, add 6 to 11 fluid ounces of Leslie's Swimming Pool Supplies Algae Control per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of Leslie's Swimming Pool Supplies Algae Control per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.
