The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the Registration Review of the above referenced product in connection with the Polixetonium Chloride Final and/or Interim Decision, and has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

HOW TO USE: [This product][brand name] is used to control the growth of algae in swimming pools, exterior spas, whirlpools, hot tubs, decorative fountains and containerized ponds that **do not** contain fish. For maximum effectiveness, pools, spas, whirlpools, hot tubs, decorative fountains and containerized ponds containing heavy growth of algae must be cleaned prior to using this product. Before draining a treated swimming pool, exterior spa, whirlpool, hot tub or decorative fountain, contact your local sanitary sewer and storm drain authorities and follow their discharge instructions. Do not discharge treated swimming pool, exterior spa, whirlpool, hot tub or decorative fountain water to any location that flows to a gutter or storm drain or natural body unless discharge is allowed by state and local authorities.

ROUTINE USE: For pools having just visible algae growth add an initial dose of 11 to 16 fluid ounces of [this product][brand name] per 10,000 gallons of water and remove settled algae. For treatment of freshly cleaned and filled pools, add 6 to 11 fluid ounces of [this product][brand name] per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of [this product][brand name] per 10,000 gallons of water must be made every 5 to 7 days after initial treatment for maintenance.

Spas, whirlpools, hot tubs, decorative fountains and containerized ponds having just visible algae growth require an initial dose of 1 to 2 fluid ounces of [this product][brand name] per 1,000 gallons of water. For treatment of a freshly cleaned spa, whirlpool, hot tub, decorative fountain or containerized pond, add 0.6 to 1.1 fluid ounces of [this product][brand name] per 1,000 gallons of water. Subsequent additions of 0.2 to 0.4 fluid ounces of [this product][brand name] must be made every 5 to 7 days after initial treatment for maintenance.

[This product][brand name] will prevent growth of most algae during the off-season winter months when pools are not in use. For pools that have been properly treated during the swimming season and are free of visible algae, add 6 to 10 fluid ounces of [this product][brand name] per 10,000 gallons of water. If at the end of the swimming season pools have some visible algae growth, add 12 to 16 fluid ounces per 10,000 gallons. It is necessary that a uniform distribution of [this product][brand name] throughout the water and the pool be made for maximum effectiveness. If pool is not covered, it may be necessary to repeat the treatment one or more times during the off-season.

[This product][brand name] is compatible with those chemicals normally used to treat pools and spas and is effective at both acid and alkaline pH. [This product][brand name] can be used in pools and spas treated with chlorine chemicals and may reduce the amount of those chemicals normally required. However, **do not** mix [this product][brand name] with concentrated dry or liquid chlorine products.
