Under the Federal Insecticide, rangicide, and Rodenticide Act as amended, for the pesticide, registered under EPA Reg. No. //435 -6

DANGER. Corrosive. Causes irreversible eye damage and skin burns. May be fatal if swallowed or inhaled. Harmful if absorbed through skin. Do not get in eyes, on skin, or on clothing. In addition, individuals who enter treatment cylinders must wear properly fitting, well-maintained, high-efficiency respirators equipped with an organic vapor-removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C) or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G), or a NIOSH respirator with an organic vapor cartridge or canister with any R, P, or HE prefilter.

Protective clothing must be replaced when it shows signs of significant contamination. Applicator must leave all protective clothing, work shoes or boots, and equipment at the treatment plant. Everlast CQ wood preservative should be used to treat any wood product that will be exposed to conditions favorable to rot or decay both above ground and in ground, or in fresh water. Types of products include lumber, timbers, landscape ties, fence posts, building and utility poles, decking, joists, trim and fascia, and wood for interior construction.

Prepare a treating solution of Everlast CQ by diluting with water to a concentration of 0.05 to 4.0 percent active ingredients. Dilution of Everlast CQ and delivery of the diluted solution to the treating cylinder must be performed in a closed system. Adjust the final concentration of the treating solution so as to yield a preservative retention of 0.15 to 0.60 pounds per cubic foot. Impregnation procedures must adhere to the current standards of the American Wood Preservers' Association. A final vacuum step should be use to remove excess treating solution from the surface of the wood before removal from the treating cylinder.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
