


GENERAL INFORMATION

Pressure-treating wood products with Everlast CA-B2 provides protection against termites, ascomycetes, white rot, brown rot and dry rot.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not use this product without reading the Manual and having the necessary safety equipment.

Everlast CA-B2 is only for use in pressure-treating wood products. Apply using vacuum pressure impregnation with water solutions having concentrations ranging from 0.1% - 3.0% active ingredients by weight. Impregnation procedures must rigidly adhere to the current specifications of CP Chemicals, Inc. or the American Wood-Preservers' Association.

The processes used to apply Everlast CA-B2 formulations must leave no visible surface deposits on the wood. Visible surface deposits indicate a surface residue or crystallization on the treated wood. Small, isolated or infrequent spots of chemical on otherwise clean wood are permitted.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

PESTICIDE STORAGE: Store in a cool, dry and well ventilated area. Keep in tightly closed containers. Store away from incompatible materials. Protect containers from physical damage. Observe all applicable local, state and federal guidelines for storage and disposal.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law.
