

# CLEAR TREET

CLEAR TREET is a specially formulated algaecide for use in home and public swimming pools for the correction and prevention of algae.

## COMPOSITION

## APPLICATION

For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using CLEAR TREET.

For pools having just visible algae growth add an initial dose of 12.5 oz. to 19 fl. oz. of CLEAR TREET per 2,000 gal. of water and remove settled algae debris by cleaning.

For treatment of a freshly cleaned and filled pool, add initially 7 to 12.5 fl. oz. of CLEAR TREET per 2,000 gal. of water.

To maintain pools free of visible algae growth, subsequent additions of 2.25 to 4.5 fl. oz. of CLEAR TREET per 2,000 gals. of water should be made every 5 to 7 days after the initial treatment.
