MIXING INSTRUCTIONS: NO-CRAB must be thoroughly dissolved. Fill the spray equipment reservoir about half full of water and add the required amount of herbicide and surfactant with agitation. Finish filling the reservoir with water and apply. After use, clean equipment thoroughly by flushing with water. Do not store spray solution in tank for a prolonged period.

Do not apply with hose-end applicators.

NO-CRAB is to be used for destroying Crab Grass in established turf except Centipede, Carpet and St. Augustine grasses. It is also recommended for controlling Dallis Grass.

Early treatment. It is preferable to use NO-CRAB in the seeding or early branched stage, however, it will control all stages. For best results, good soil moisture is essential. When applied during periods of drought, a thorough watering of the area is necessary prior to application. Keep area mowed at from 1" to 1½" during treatment. New lawns or areas should not be treated until after 3 mowings. Wanted grasses may be temporarily affected, especially during hot, dry weather. The more sensitive Bent and Fescue grasses may be temporarily discolored. Thorough watering will usually revive them. The more persistent Blue-grasses, Zoysia, Bermuda are not usually affected. Do not use on Centipede, Carpet, St. Augustine grass or Dichondra. For each 1000sq. ft. of area, apply 3 fluid ounces of NO-CRAB plus a suitable surfactant. Mix in 10 gallons of water. Thoroughly wet all crab grass. For best control, two applications 10 to 14 days apart is generally required. Repeat treatment as necessary.

For Dallis Grass: Apply at the rate of 2-3 fluid oz. of NO-CRAB plus a suitable surfactant mixed with 10 gallons of water per 1000 sq. ft. Repeat two or more times every 10 to 14 days. Observe the same precautions as for Crab Grass control.
