DIRECTIONS

JAPANESE BEETLE, WHITE GRUBS, WHITEFRINGED BEETLE AND WIRE WORNS — Mix 1 gallon of FIGHT with 200 gallons of water to cover one acre. After applying, wash into soil. This will give control for one season. To give up to 10 years control, apply at the rate of 2 to 4 gallons of FIGHT in 500 gallons of water to cover one acre.

SOD WEB WORMS — Water thoroughly before applying. Apply FIGHT at the rate of 1 to 2 gallons in 200 gallons of water to cover one acre. Do not water for several days after treating.

ANTS — Apply ½ gallon of FIGHT, mixed with 100 gallons of water to cover one acre. Soak the colonies of ants with the above solution.

APHIDS AND SPIDER MITES ON ORNA-MENTALS — Mix FIGHT at the rate of 2 ounces per gallon of water. Spray thoroughly with a wet coarse spray. Repeat when necessary. When treating for aphids and spider mites, re-apply every 2 or 3 weeks or when the insects reappear.
