

SUNBUGGER #11 LIQUID RESIDUAL SPRAY

PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Allow treated areas to dry before reentry. Contact with skin, eyes or clothing should be avoided. Wash thoroughly with soap and water after handling. Do not apply directly to food. In commercial food handling facilities, cover or remove any food or food processing equipment during application. Do not apply while food processing is underway. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Cover exposed food. Remove pets and cover fish bowls before spraying. If poisoning occurs, obtain prompt medical attention.

STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Flush with plenty of water. Get medical attention if irritation persists.

IF SWALLOWED: Drink one or two glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. Call a physician.

IF INHALED: Remove victim to fresh air if effects occur and call a physician.

IF ON SKIN OR CLOTHING: Remove contaminated clothing. Wash skin with soap and water. Get medical attention if irritation persists.

Note to Physician: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.

ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds, and wildlife and vegetation. Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS

Do not spray into or near open flames.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

Do not contaminate water, food, or feed by storage or disposal. **PESTICIDE DISPOSAL:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent), and offer for recycling, reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not use in edible areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings. Before using on fabrics, wall paper and certain floor tiles, test spray in an inconspicuous area to avoid staining.

Kills ants, cockroaches, spiders, silverfish, centipede, brown dog ticks, clover mites, crickets, earwigs, millipedes, mosquitoes, paper lice, sandflies, scorpions, sowbugs, spiders, firebrats, Exposed stages of caddisflies, cigarette beetles, dermestids, drugstore beetles, Indian meal moths, red flour beetles, sawtooth grain beetles and weevils. Use outdoors only to control fleas, flies, gnats, mosquitoes, punkies, and sandflies. Insect killing power lasts up to two weeks indoors. Spray only on surface. **DO NOT USE AS SPACE SPRAY.**

SPOT TREATMENT TO KILL ANTS, ROACHES, CRICKETS, SILVERFISH, SOWBUGS, SPIDERS, AND EARWIGS: Spray into cracks and crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Contact directly as many insects as possible. For ants, spray trails and places where ants enter premises. Repeat as necessary for control.

GENERAL: Apply with a low pressure sprayer equipped with a coarse spray nozzle. Spray surfaces only until wet. Avoid excessive run-off. Repeat as necessary. Do not spray vegetation.

APPLY THIS PRODUCT ONLY AS SPECIFIED ON LABEL.

COCKROACHES: Thoroughly treat infested areas. Spray baseboards, cracks and crevices, around window and door frames, the under surfaces of shelves, drawers, and work tables, behind and beneath cabinets, refrigerators, sinks, stoves, in and around waste containers, switch panels, junction boxes, floor drains and other places where cockroaches hide or rest. De-energize electrical equipment prior to application.

ANTS: Apply to trails and places where ants enter premises such as door sills and window frames. Spray hills and runways outdoors.

SILVERFISH, FIREBRATS AND PAPERLICE: Spray into cracks, crevices, around baseboards and other places where insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Repeat as needed.

CADELLES, CIGARETTE BEETLES, DERMESTIDS, DRUGSTORE BEETLES, INDIAN MEAL MOTHS, MEDITERRANEAN FLOUR MOTHS, RED FLOUR BEETLES, SAW TOOTH GRAIN BEETLES AND WEEVILS (Exposed Stages) IN FOOD STORAGE AREAS AND FOOD PROCESSING PLANTS: Cover any exposed food products, equipment, or packaging equipment or materials. Do not use in edible product areas. Thoroughly treat floors and walls of the infested areas with attention to cracks, crevices, corners and perimeters. Sanitation and dust control are of primary importance. Fumigate or destroy infested products.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floor. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES, CENTIPEDES, SOWBUGS, SCORPIONS AND SPIDERS: Spray into cracks, crevices, around baseboards, window and door frames and exterior perimeter of the infested premises. For clover mites give special attention around window frames.

FLEAS, FLIES, GNATS, MOSQUITOES, PUNKIES AND SANDFLIES (outdoors only): Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, and other areas where insects may enter.

HORNETS AND WASPS: Apply liberally after dark when all the insects have returned to the nest.
