CAUTION

PHYSICAL OR CHEMICAL HAZARDS

Flammable: Keep away from heat and open flame. Water dilutions should be prepared at room temperatures. Exposure to low temperatures may cause cloudiness or crystallization. Prepare only the amount required for immediate use.

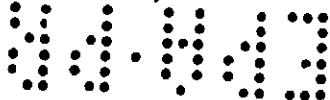

SURFACE SPRAY

This concentrate should be diluted with water before use, at a rate of 1 part concentrate to 9 parts water. The diluted spray should be applied in conventional mechanical or compressed air equipment. It is not recommended for use in thermal generating equipment.

To control cockroaches, ants, spiders, silverfish, crickets, centipedes, earwigs, sowbugs, and grain mites:

- Apply as a coarse droplet spray directed into cracks, crevices along baseboards, around the base of machinery and under pallets.
- Treat all returned home cartons and cases. Spray thoroughly contacting insects directly whenever possible.
- Spray badly infested areas daily. In other areas repeat treatment twice weekly or when reinfestation occurs.
