**PRECAUTIONARY STATEMENTS

STATEMENT OF PRACTICAL TREATMENT**

**IF SWALLOWED:** Call a physician or poison control center immediately. Gastric lavage is indicated if material was taken internally. **DO NOT INDUCE VOMITING.** Vomiting may cause aspiration pneumonia.

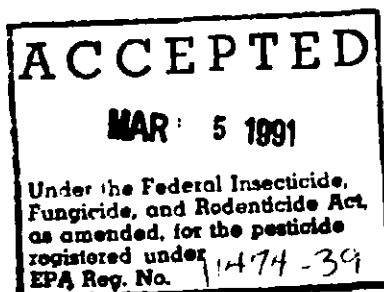

**ROACHES, ANTS, SILVERFISH, SPIDERS, CRICKETS:** Spray heavily into all cracks, around baseboards and other places where these insects hide. Also behind and beneath cabinets, refrigerators, sinks, doors, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

**CARPET BEETLES:** Make localized application to the baseboards. Spray directly into cracks, closets and infested areas of shelving. Repeat as necessary. Do not use on floors or furniture.

**BROWN DOG TICKS:** Thoroughly spray infested areas around baseboards, window and door frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. **DO NOT TREAT ANIMALS WITH THIS FORMULATION.**

**FLIES, MOSQUITOES, WASPS AND FLYING MOTHS OUTDOORS:** For outdoors, use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insect alight or congregate.

**FLEAS, ANTS, BROWN DOG TICKS, CLOVER MITES, CRICKETS, EARWIGS, MILLIPEDES OUTDOORS:** For treatment of localized infestations of these insects in outdoor areas or where these insects may enter the dwelling, spray infested areas thoroughly. For Ants, thoroughly wet hills and runways. Repeat treatment as necessary. Do not spray vegetation.

**STORAGE AND DISPOSAL**

**STORAGE:** Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE DISPOSAL:** Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**CONTAINER DISPOSAL:** Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.
