- 1. To protect against repeated skin exposure, add a statement to wear gloves (mitts) when treating pets since directions state to "fluff the hair so that the spray will penetrate to the skin."
- 2. Add the statement "Do not use this or any other pesticide on sick, old, or debilitated pets."
- 3. Revise the Precautionary Statement as follows:

Harmful if swallowed. May be absorbed through skin. Avoid inhalation of spray mist. Avoid contact with skin, eyes, or clothing. Wash thoroughly after handling and before smoking or eating.
