This product contains a wetting agent for better coverage. Do not apply any water within 4 days. If rain or irrigation occurs within 4 days, repeat treatment. Tall, hard grasses may require several treatments. One gallon of this material when mixed with an equal amount of water will treat from 300 to 1000 square feet of ice plant, depending on size and amount of weeds.
