FLEAS AND OTHER INSECTS IN CARPETS AND UPHOLSTERY Keep people and pets off treated carpet and upholstered furniture during treatment and until area is vacuumed.

Test hidden surface of carpet or upholstery before treating. If texture or color is affected, do not use.

Shake well before using. Punch plastic seal if present.

Carpet Treatment: Hold upside down and shake powder evenly across surface. Brush lightly with a broom to allow powder to penetrate carpet fibers. Walt 60 minutes, then vacuum. For severe problems or where ticks are known to be hiding, wait 2-3 hours before vacuuming. If powder adheres to a spot, brush it out and vacuum immediately. Apply to dry surfaces only. Do not allow powder to become wet. Clean carpet after using this product.

Upholstery Treatment: Remove all loose cushions. Sprinkle along creases, in corners. Brush gently, wait 60 minutes, vacuum. Sprinkle along underside of furniture. Do not use on exposed fabric; may cause staining. Remove bag from vacuum cleaner. Wrap securely in several layers of newspaper and discard in trash.

FLEAS AND OTHER INSECTS ON AND AROUND DOGS, CATS AND PREMISES

To Control Fleas & Ticks on Dogs & Cats:

Liberally apply powder to the animal, rubbing thoroughly to the skin. Begin with the neck and include the underbody, legs, feet and the base of the tail. Take care not to pet the powder in animal's eyes, nose or mouth.

Do not treat puppier or kittens less than 12 weeks of age. Do not apply directly to genitalia.

Do not repeat treatment for 7 days.

Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication.

Kennels: Surfaces of kennels should be dusted at the rate of (one) ounce per 50 square feet. Repear as necessary.

Heavily infested basements, and crawl spaces: Should be dusted at the rate of (16) ounces per 1000 square feet. Repeat as necessary.

FIRST AID
