## FOGGING OIL, INSECTICIDE WITH SLUDGE INHIBITOR

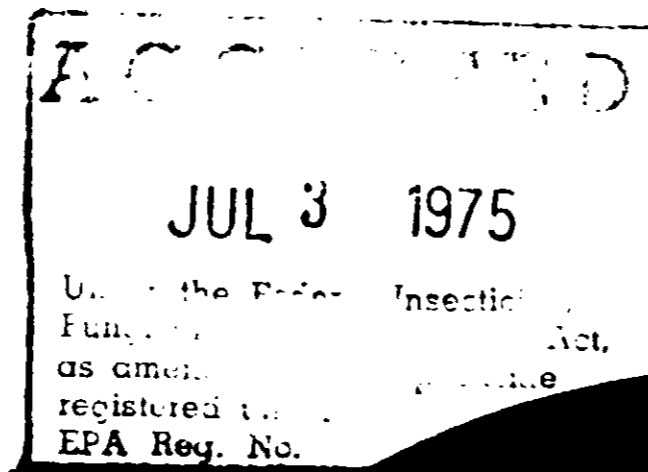
FOGKILL should not be diluted but used "as is", in any type fogging or thermal applying equipment. FOGKILL contains Lethane 384 for fast knockdown and clean-out, Malathion (low odor) for high kill, and Thio-spense\* Sludge Inhibitor for preventative machine maintenance. Apply at the rate of one gallon to approximately 10,000 square feet of surface area. Completely envelop area in accordance with the equipment manufacturer's recommendations.

**MOSQUITOES AND GNATS:** Envelop total outdoor area to be treated with a coarse fog or fine spray. Pay particular attention to all zones of stagnation. Application of this product to any body of water is prohibited.

**FLIES:** Envelop in a fine fog or mist. Use fog in killing flies in horse stables, rubbish piles and open sewage areas. Take care to avoid heavy applications to ornamental plants and when used over shallow waters. DO NOT USE IN DAIRY BARNES OR ON LIVESTOCK INTENDED FOR SLAUGHTER.
