DIRECTIONS FOR USE

Spray infested surfaces only until wet.

ROACHES, ANTS, WATERBUGS, SILVERFISH, SPIDERS, CRICKETS: Spray thoroughly into all cracks and around baseboards. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Repeat treatment as required.

CARPET BEETLES: Make localized application to areas of the floor and baseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings.
