## DIRECTIONS FOR USE

### FOR INDOOR USE ONLY

#### To Kill Houseflies, Mosquitoes and Gnats

Close windows and doors. In homes cover or remove exposed foods. Avoid contamination of cooking utensils and food preparation surfaces. Wash thoroughly before reusing. Spray freely toward ceiling in all directions until room is filled with mist, then leave the room. Keep doors closed for at least 15 minutes. Ventilate the room when treatment is completed. Sweep up and destroy fallen insects. Repeat treatment as necessary.

#### To Kill Wasps

Application should be made in late evening when insects are at rest. Spray liberally into hiding and breeding places contacting as many insects as possible. Repeat as necessary.

## STORAGE AND DISPOSAL

**STORAGE:** Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.

**DISPOSAL:** Pesticides that cannot be used should be disposed of according to procedures approved by Federal, State or Local disposal authorities. Triple rinse (or equivalent) the empty container and dispose of in an approved landfill or bury in a safe place. Do not reuse container. Consult Federal, State or Local disposal authorities for approved alternative procedures.
