Preparation and Directions for Using Container:

- 1) Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets and birds, cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger (newspapers may be used).
- 2) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Extinguish all flames and pilot lights. Do not use sprayer in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.
- 3) Place a chair, table or stand in the center of the room to be fogged. Cover with several layers of newspaper or paper towels.
- 4) SHAKE CAN WELL. Break off and remove tab on side of sprayer. Tilt sprayer AWAY from face (container sprays straight up). Press down firmly on sprayer pad until it snaps into place.
- 5) Set fogger on covered stand. Immediately leave treated area.
- 6) Keep treated area closed for at least two hours. Before reoccupying area, open all doors and windows and allow treated area to air for 30 minutes.

STORAGE AND DISPOSAL

STORAGE: Store away from heat or open flames in an area inaccessible to children.

DISPOSAL: Do not reuse empty container. Wrap container and put in trash.

DESCRIPTION OF PRODUCT:

This product can also be sold with a Spray & Fog actuator, which has a special valve that allows half the product to be sprayed while holding the container inverted. Sufficient product will remain to fog a predetermined area with 1.3oz/1000 cubic feet. This product allows the user to pre-treat the heavily infested areas of the home before fogging. Following are the 'directions for use' for the Spray & Fog. The remainder of the label is the same as above.

**PRO-CONTROL
SPRAY & FOG**

SHAKE WELL BEFORE USE.

The 2-way system to spot spray and then fog for complete roach and flea control.

- * Spray kills on contact
- * Fog seeks out bugs where they hide

One can will spot spray and fog a room of up to 15' X 22' X 8' of space. Use half the can for spot spraying and half the can for fogging.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Preparation and Directions for Using Container:

REMOVE or cover exposed foods, dishes, utensils, food processing equipment and surfaces. REMOVE pets, cover and turn off or remove fish tanks and bowls. OPEN cupboards, cabinets, closets, trunks, and doors to area being treated. COVER waxed wood floors, waxed furniture and molded plastic stereo dust covers in the immediate area surrounding the fogger. (Newspapers may be used.) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. EXTINGUISH ALL FLAMES AND PILOT LIGHTS. Do not use sprayer in a cabinet or under a counter or table. Use only one can in rooms 12' X 12' or smaller.

1) Spot spray tough bug areas:

Spot spray hard to reach areas where insects tend to hide, such as in cabinets, under appliances, in corners, over carpets and other infested areas.

- * Shake can.
- * To spot spray, hold can upside down and press button on side of sprayer.

BEST AVAILABLE COPY

- * After spot spraying or when spray stops, follow fogging directions below.
- * Note: Special two-way valve will stop spraying after half the can is used in the upside down position.

2) Then fog the room:

- * Place newspaper on stand or table in center of room.
- * Hold can upright - away from face - shake can.
- * Turn cap all the way to the right until fog starts.
- * Place can on newspaper pad, leave room and close door. Keep room closed for at least two hours before airing out. Open all doors and windows and allow treated area to air for at least 30 minutes before reentering.
